## Computer Use Agreement Contract

The Court/USPC has authorized CSOSA to monitor your computer use as indicated on your most recent probation/parole order. Although you are allowed to use computers for legitimate purposes, the Court/USPC has prohibited you from using computers to access pornography, communicate with others through chat services, view pornographic CDs, download sexually-oriented articles or stories, to e-mail children or the victim or other prohibited persons, or create sexually-oriented documents.

In order to comply with the Court's/USPC's order, you must agree to the requirements listed in this contract and sign said contract. Failure to agree to adhere to all of these requirements will cause CSOSA to notify the Court/USPC that you refuse to comply and therefore are in violation of the probation/parole order. Please initial next to each specified requirement after a CSOSA representative explains it to you and sign at the bottom of the document.

\_\_\_\_\_ I understand that I may only use the computer equipment specified within this contract (see page 3) and that use of any other computer equipment will be considered a violation of this special condition.

\_\_\_\_\_ I understand that I must notify any and all persons who have access to the same computer equipment as I that the equipment will be monitored by CSOSA and that any peripheral items associated with the computer may be seized by CSOSA if my possession of them is deemed inappropriate by CSOSA.

\_\_\_\_\_ I will provide all personal/business phone records and credit card bills to CSOSA upon request so that they can determine whether I have undisclosed Internet service accounts.

\_\_\_\_\_ I must obtain prior written approval from CSOSA to use an electronic bulletin board system, Internet relay chat channel, DCC chat channel, newsgroup, user group, or any site-based e-mail which provides some measure of anonymity (such as Hotmail or Yahoo).

\_\_\_\_\_ I understand and agree that using a computer for any purpose which might further sexual activity is strictly prohibited, such activities include, but are not limited to, the following: possession of sexually-explicit material in any form; sexually-related "chat" or e-mail exchange; visiting or joining "chat rooms" which contain sexually-explicit conversations; visiting/viewing sexually-explicit material on web sites; visiting voyeuristic web sites or "live cam" websites that contain nudity or sexually-explicit materials; downloading binary files, UUE files, MIME files, AVI files, MPG files, Real Player files, digital images in any format, text files, or multimedia material that is sexual in nature; or visiting and/or subscribing to usergroups, newsgroups, or list servers, which focus on or contain sexual content.

\_\_\_\_\_ I accept that I shall be prohibited from using any form of encryption, cryptography, steganography, compression, password protected files and/or other method that might limit access to, or change the appearance of, data and/or images without prior written approval from my CSO.

\_\_\_\_\_ I agree to consent to unannounced examinations by CSOSA of any and all computer(s) and/or electronic devices(s) to which I have access for the purpose of detecting content prohibited by this document. This includes access to all data and/or images stored on hard disks, "Zip Disks", floppy diskettes, CD ROMs, optical disks, cell phones with photographic capability, magnetic tape and/or any other storage media whether installed within a device or removable and separate from the actual computer device.

\_\_\_\_\_ I will provide CSOSA with a current list of all computer equipment I use, including back-up systems, and will keep this list current.

\_\_\_\_\_ I agree to install, or allow to be installed at my own expense, equipment and/or software to monitor or limit computer use; or to remove any hardware device including modem, network card, and/or other device that may be used to provide access to another computer or computers. I understand that I have no expectation of privacy regarding my computer use or information stored on the computer if monitoring software is installed. I further understand and agree that information gathered by said monitoring software may be used against me in subsequent court or USPC actions regarding my computer use and conditions of probation or parole.

\_\_\_\_\_ I agree to be fully responsible for all material, data, images and information found on any computer I am designated to use at all times.

\_\_\_\_\_ I specifically agree and voluntarily consent that his/her computer may be examined and/or searched at any time, announced or unannounced, by CSOSA to verify compliance with these special conditions of supervision. I understand and agree that any computer-related equipment, and storage devices are subject to seizure and/or removal by CSOSA if, during an examination of the computer or other media, CSOSA finds any evidence of inappropriate or prohibited computer use.

\_\_\_\_\_ I understand and agree that CSOSA will remove any illicit material from my computer(s) and "wipe" slack space and unallocated space on the hard drive(s).

\_\_\_\_\_ While CSOSA represents that there are no known conflicts or defects in the software packages they will use on the computer equipment I am authorized to use, I accept all responsibility and risk for the computer software installation and use on the equipment I am authorized to use. Further, I agree to hold CSOSA harmless for any direct, indirect, incidental, special, or consequential damages whatsoever, including but not limited to, loss of revenue or profit, lost or
